Her pivotal role as a founding member of in initiating the Palestinian Association of Family Medicine has created opportunities for continuing education, training supervisors for students and residents, improving quality of patient care, and networking between colleagues in the West Bank, Gaza and globally. This speaks volumes about her leadership and vision in developing comprehensive family focused primary care in her community and the region. This is inspite of the ongoing political and safety challenges in the area.

Presently, as an Assistant Professor at An Najah National University, she continues to impart knowledge and inspire future generations of healthcare professionals. - •Dr. Wael Al-Daghli spoke about the early detection program for hearing loss.
- •There was a lecture by WHO Nutrition Consultant Dr. Mahmoud Bouzo on the new recommendations in cow's milk allergy the new diagnostic hair.
- •Dr. Saba Rihawi, a member of the Scientific Council of the Syrian Board, gave a lecture on common mental disorders in primary health care, as well as Dr. Samar Al-Moazen, President of the Syrian Association of Family Medicine, gave a lecture on promoting women's health between prevention and early detection of diseases.










The Saudi Society of Family and Community Medicine

The Saudi Society of Family and Community Medicine celebrated obtaining the Guinness World Records certificate for achieving a new record by gathering the largest number of supporters for the awareness campaign on shingles. This record was achieved through the campaign held at Boulevard City in Riyadh, shedding light on the effects of shingles, its negative impact on the affected individuals, and preventive measures. During the event, inquiries related to the nature of the disease, its potential spread among men and women, causes, common complications and ways to deal with them were addressed. The presentation also highlighted prominent preventive measures to avoid contracting the disease, targeting age groups most in need of vaccination.



Dr. Ashraf Amir, Deputy President of the Saudi Society of Family and Community Medicine, praised the large interaction from the audience, indicating the keen interest in health education and raising awareness about various diseases. 

Dr. Abdulaziz Al-Mahrezi bio

Dr. Abdulaziz Al-Mahrezi has held various leadership positions at the international, regional, and national levels. At the international level, he was the President Elect of the East Mediterranean Region (EMR) of the World Organization of Family Doctors (WONCA) from June 2021-November-2023. At the regional level, Dr. Al-Mahrezi is a founding member of the Gulf Association of Family Medicine since May 2023.

At the national level, he has held several significant leadership roles. He is currently the Director General of Sultan Qaboos University Hospital (SQUH), the only academic hospital in Oman, since May 2022. He served as the Head of Family Medicine & Public Health for six years from 2014 to 2020. Additionally, he was the President of Oman Family Medicine Society from 2018 to 2023. He has also held other leadership positions within the hospital, including the chair position of the University Health Committee.

His Clinical Achievements were being the First Omani Fellow of the College of Family Physicians of Canada as well as the First Omani physician to complete family medicine residency training at McGill University, Montreal, Canada.

Dr. Abdulaziz Al-Mahrezi has made significant contributions in the field of academic teaching and learning as well as research. He has received several awards and recognition for his contributions, including certificates of appreciation for his work in the development of the Integrated Clinical Examination and the conduct of the Final MD examination. He has also been recognized for his valuable participation as an examiner in international membership examinations. In terms of research, Dr. Al-Mahrezi has published numerous articles in reputable journals, with a total of 42 journal publications. His research has focused on various topics such as hypertension management, chronic pain, medical education, and infectious diseases.

Dr. Al-Mahrezi's leadership positions demonstrate his commitment to advancing healthcare at various levels, from international organizations to regional and national healthcare institutions.
